




### **RELATIVE INTENSITY vs. WAVELENGTH**




#### SPATIAL DISTRIBUTION




### **REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS**



TAPE SPECIFICATIONS (units : mm)




REEL DIMENSION (units : mm)
